Video Conference Meetings - This meeting, as it included the nominations, was the first meeting we have conducted under changes to the International Constitution allowing for remote attendance. While there are going to be some technical and procedural challenges conducting meetings in this fashion, we are glad to have contributed to this important change so members have the ability to get information directly even when the meetings are not geographically close to them. The Local Executive will be reviewing how things went, and making recommendations for future meetings to help things run as smoothly as possible. We will also be hosting additional check up meetings in the interim to test things out and give people more opportunities to be connected. These meetings will include area meetings, as well as meetings for individual committees. Be on the look out for a schedule to be published for October. A motion was passed for a budget of \$2500.00 to purchase some additional A/V equipment to facilitate meetings like this in the future (computer, projector, microphones, etc).

Next Meeting - The next Executive and General Meetings are scheduled for November 11, 2025 in Toronto, ON. The Executive has committed to sending out a bulletin board notice three weeks in advance of the date, as well as MTMS alerts at three weeks, one week, the day before, and the day of the meeting going forwards.
